I consent to the recording and use of my image during the Tournament. This consent also includes the use of the materials and photos taken, especially for public disclosure, media sharing, reproduction, duplication, broadcast, publication, airing, or transmission, along with the images of other people captured during the Tournament , for sports promotion activities of the City of Gdynia conducted by the Gdynia Sports Center through the dissemination of the image in:

- electronic media, especially on the websites and social media portals of the Gdynia Sports Center and the Municipality of Gdynia, such as Facebook, Instagram, YouTube, Twitter;
- press and television;
- electronic media, especially on the websites and social media portals of sponsors and partners for informational and marketing purposes;
- brochures, leaflets, newsletters, etc.

This consent for the use of the image is voluntary, free of charge, and not limited in time or territory. The conditions for data processing have been specified in the Information Obligation.

GDPR INFORMATION OBLIGATION

1. In accordance with Article 13(1) and (2) of the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as GDPR, I inform you that the administrator of your personal data is Gdynia Sports Center, hereinafter referred to as the "Administrator," based in Gdynia (postal code 81-538) at 5/9 Olimpijska Street.
2. You can contact the Administrator through the Data Protection Officer appointed by them by writing to: [iod@gdyniasport.pl](mailto:iod@gdyniasport.pl).
3. Your personal data is processed for the following purposes:
  - registration and participation in the Tournament based on Article 6(1)(a) of the GDPR,
  - recording and publishing the image under the terms specified in the consent, in accordance with Article 6(1)(a) of the GDPR.
4. Your personal data will be processed for a period of 25 years, considering the provisions of the Act of July 14, 1983, on the national archival resources and archives, and the Regulation of the Minister of Culture of September 16, 2002, on handling documentation, principles of its classification and qualification, and the rules and procedures for transferring archival materials to state archives.
5. The provision of personal data is voluntary, but the lack of consent makes it impossible to participate in the Tournament. Processing of personal data in the form of an image is voluntary; lack of consent enables participation in the Tournament.
6. Your personal data will be disclosed to entities involved in organizing the Competition (company handling registrations), providers of technical and organizational solutions, and other entities based on legal provisions and concluded data processing agreements. It is anticipated that the image will be made available in the form of recorded materials to the Tournament sponsors and partners, as well as Facebook Ireland Limited, Instagram, YouTube, Twitter, which are based in the USA. Thus, the data may be transferred to the United States of America, where different data protection regulations apply, which may not ensure an adequate level of protection. Due to publication on social media portals Facebook and YouTube, competition participants' data will be transferred by Facebook and Google to their servers for backup and purposes related to the operation of the services.
7. The Administrator will not make automated decisions, including decisions resulting from profiling\*, based on your personal data.
8. You have the right to access your data, correct it, delete it, restrict processing, transfer data, object, and withdraw consent provided that fulfilling the request does not contradict the GDPR and other legal provisions. Withdrawal of consent will not affect the lawfulness of processing based on consent before its withdrawal.
9. You have the right to lodge a complaint with the Personal Data Protection Office if you believe that the processing of your data violates the GDPR.
10. According to Article 14 of the GDPR, your personal data, i.e., name and surname, age, and gender, were provided at the registration stage for the Tournament.
11. The Administrator also informs you that photos will be taken during the Tournament to inform and promote the event and the activities of the Gdynia Sports Center, considering the provision of Article 81(2) of the Act on Copyright and Related Rights, according to which permission is not required to distribute the image of a person commonly known, if the image was made in connection with the performance of their public functions, especially political, social, professional functions, as well as a person who is a part of a larger whole such as a gathering, landscape, or public event.

\*Profiling means any form of automated processing of personal data that involves the use of personal data to evaluate certain personal factors of a natural person, in particular to analyze or forecast aspects concerning the work of that natural person, their economic situation, health, personal preferences, interests, reliability, behavior, location, or movement.
